Together we have extensive understanding and experience in autism and learning disability and in delivering the Tier 2 Oliver McGowan Mandatory Training on Learning Disability and Autism. We have also been chosen by NHS England to deliver the 4-day Lead Trainer Training across England.

Training courses are organised in tiers which align to the Core Capabilities Framework. We deliver Tier 2 training. For more information, see MHS tier guidance.

- A 1-day course, which consists of 2 x 3.5-hour sessions:
 - Session 1 learning disability;
 - Session 2 autism.
