# Due Diligence Statement: All-Party Parliamentary Group on Autism

#### 1. Summary

From 16 October 2023 a new rule came into effect prohibiting APPGs from accepting secretariat services that are either provided or funded by a foreign government.

This statement declares that the APPG on Autism is not provided by or funded by a foreign government.

### 2. The All-Party Parliamentary Group on Autism

The All-Party Parliamentary Group on Autism is a cross-party group of MPs and Peers. The purpose of the group is to campaign in Parliament for greater awareness of autism, and to lobby the Government for improved services for autistic people and their parents and carers. Its secretariat is provided by The National Autistic Society.
